## Entry Procedure

### Entry Procedure

1. Listen for the on-air cue to call and call the station competition line

3. The entrant must listen to the audio clip played by the Promoter and attempt to correctly identify the three (3) songs by the song title and artist;
4. If the entrant provides a correct guess, in accordance with the Judging Details, they will be awarded a cash amount as determined by the Promoter;
5. The total prize pool may not be fully awarded by the end of the Contesting Period, as the amount awarded is dependent on entrants correctly identifying songs during their participation
